## PROPOSED ROUTE SUMMARY

Route 26 will now run between Bankhead Station and Hamilton E. Holmes Stations along Perry Blvd., Bolton Rd., Northwest Dr., Browntown Rd., James Jackson Pkwy. and Hamilton E. Holmes Dr. The midday frequency of this route will be upgraded to **30 minutes**. Alternating trips will have a midday frequency of **60 minutes**. For more details, refer to the table below.

Most of the segment along W. Marietta St. between Marietta Blvd. and Five Points Station will be discontinued. Service within the Carver Hills neighborhood will be transferred to the Proctor Creek/ Westside Park On Demand Zone. Segments along Northwest Dr., Browntown Rd., James Jackson Pkwy. and Hamilton E. Holmes Dr. will be now be served by this route instead of Route 153. Also the segments along Northwest Dr., James Jackson Pkwy., and Browntown Rd. will be served with alternating trips. Service along Peyton Rd. between Bolton Rd. and James Jackson Pkwy. will be discontinued.

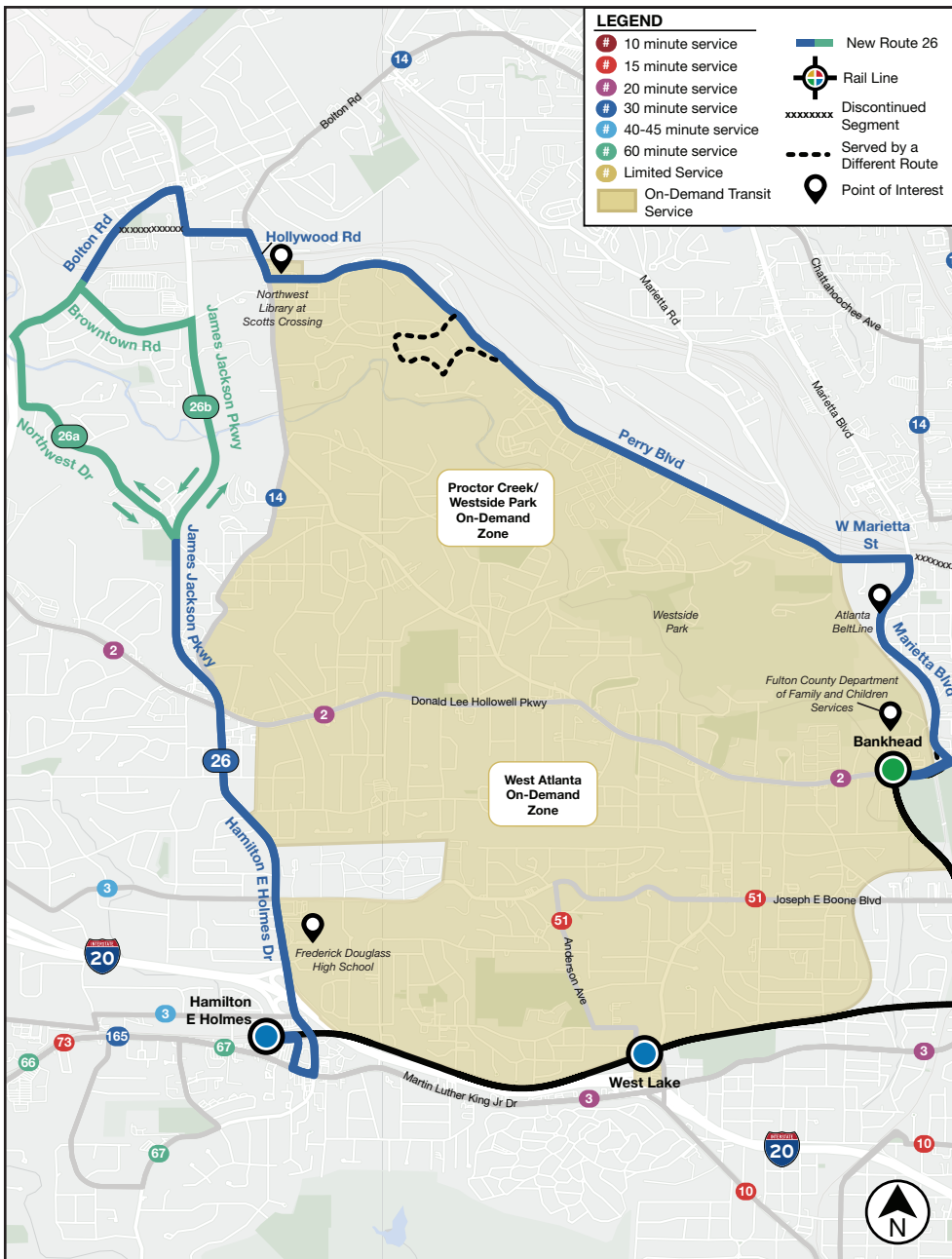
